Many companies and tax agents have benefited from the convenience of e-Filing Form C-S since 2012. To benefit more companies, e-Filing will be available for <u>both</u> Form C-S and Form C from early Jun 2015.

Offline	Download and complete Form C (PDF format) at your own time and convenience, in your local machine. When Form C is ready for submission, upload it with your tax computation, financial statements, detailed profit & loss statement and other supporting documents via mytax.iras.gov.sg.	Suitable for tax agents / companies who need to show their clients / management the completed Form C to obtain approval prior to submitting it to IRAS.	Available from early Aug 2015

## e-Filing is Easy - These are the Steps

- 1) Retrieve your company's e-Services Access Code
- 2) Authorise yourself or a third party as an Approver for Corporate Tax Matters via the e-Services Authorisation System
- 3) Log in to mytax.iras.gov.sg
- 4) Submit the completed Form C-S / Form C online or upload Form C (pdf format) online
- 5) For Form C, upload the audited accounts with a copy of the detailed profit & loss statement, tax computation and supporting documents online
